Shannon Bacon, Justice Michael E. Vigil, Justice David K. Thomson, 15 Justice Julie J. Vargas, and Justice Briana H. Zamora concurring; NOW, THEREFORE, IT IS ORDERED that the petition is GRANTED and 16 17 the stipulation is ACCEPTED; IT IS FURTHER ORDERED that the petition is granted in accordance with 18 19 the terms set forth in the stipulation, including the following: 20 1. Respondent, Hon. Dev Atma S. Khalsa, shall permanently resign from judicial 21 office by 5:00 p.m. on the date of this order; 22 23

- 2. Respondent shall never again hold, become a candidate for, run for, or stand for election to any New Mexico judicial office in the future;
- 3. Respondent shall never seek appointment to, or serve *pro tempore* for any New Mexico judicial office in the future; judicial office includes the posts of judge in probate court, municipal court, magistrate court, metropolitan court, district court, Court of Appeals, and Justice of the Supreme Court; and
- 4. Respondent shall never again hold or exercise any judicial authority in the State of New Mexico, including the authority to officiate weddings;

IT IS FURTHER ORDERED that Respondent shall resign by submitting a letter of resignation to Chief Justice C. Shannon Bacon and to First Judicial District Chief Judge Bryan Biedscheid by 5:00 p.m. on the date of this order; and

IT IS FURTHER ORDERED that this matter shall remain unsealed pursuant to this Court's April 7, 2023, order and Rule 27-104(B) NMRA.

IT IS SO ORDERED.
